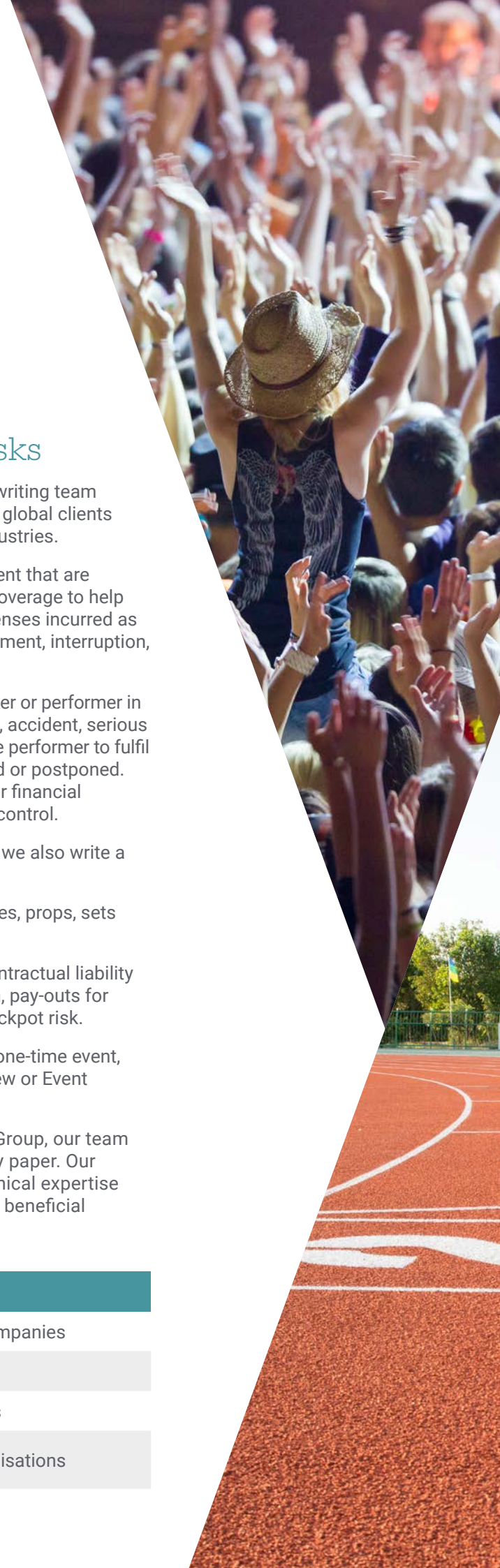
Whilst specialising in Non-Appearance and Event Cancellation – we also write a wide range of sub classes of Contingency including:
